  - b. Order Approving and Appointing an Agent for the Election;
  - c. Order Appointing an Early Voting Clerk and Deputy Early Voting Clerk;
  - d. Order Establishing and Designating Election Precincts and Polling Places;
  - e. Order Establishing and Designating Early Voting Polling Places;

- f. Order Adopting Form of Notice of District Election;
  - g. Action to approve a contract with Hart InterCivic, Inc. for election services.
  - h. To consider and take action on such other Orders, Resolutions and related matters as required or appropriate to call for the District election.

2. To approve the Minutes of prior meeting(s).
3. To receive a financial report from the District Treasurer and District bookkeeper.
4. To pay District bills, including approval of any submitted pay applications.
5. To receive the financial report, including review and action on District bills.
6. To review and take action on the payment of operations funding pursuant to budget and service agreement with the Department.
7. To review and take action on District Investments, including approval of Letters of Credit Agreements as approved collateral for District deposits.
8. To review and take action on sales tax reports.
9. To review, amend and take action on revisions to District and/or Department operating and capital budgets pursuant to quarterly re-allocations and/or other matters.
10. To receive a report from Ricardo Martinez with Joiner Architects regarding the status of the District construction projects as well as to discuss any future remodel or construction projects for the District.
11. To review, discuss and take action on any current construction matters regarding District projects.
12. To review, discuss and take action on future plans for Station remodels and construction.
13. To review and discuss the appointment of a new District commissioner to fill the Board vacancy as permitted by Texas Health and Safety Code §775.0445.
14. To discuss and take action on the ratification of a continuing Contract with a private law firm for the collection of 2015 and subsequent years delinquent District ad valorem property taxes, and providing for the payment of up to 20% of the delinquent taxes, penalties, and interest which are collected by the attorney under said Contract.
15. To discuss and take action on the imposition of additional penalty on delinquent taxes for 2015 and subsequent years pursuant to Section 33.07 of the Property Tax Code and adoption of a Resolution regarding same.
16. To discuss and take action on the imposition of additional penalty on delinquent taxes for 2015 and subsequent years to defray costs of collection by the District's delinquent tax attorney, pursuant to Section 33.08 of the Property Tax Code and adoption of a Resolution regarding same.
17. To discuss and take action on the imposition of early additional penalty for collection costs for taxes imposed on personal property on 2015 and

subsequent years delinquent taxes pursuant to Section 33.11 of the Property Tax Code and adoption of a Resolution regarding same.

18. To receive a report from Atascocita VFD.
19. To review and take action on formation of an Atascocita VFD liaison committee consisting of 2 (two) ESD Commissioners and designated members of the Atascocita VFD.
20. To review, discuss and take action on District employees' salaries. To review, discuss and take action regarding District insurance policies.
21. To review and take action on the sale and/or disposition of surplus vehicles and/or equipment pursuant to Texas Health and Safety Code §775.251.
22. To review, discuss and take action on any necessary repairs for equipment, apparatus and facilities in service to the District.
23. To review, discuss and take action on submittals by the Department of thirty (30) day advance request(s) for purchase of needed District assets.
24. To review and take action on the Joint District and Department Long Range Plan.
25. To review and take action on designation of Public Information officers and procedures for accepting and responding to requests under the Texas Public Information Act.
26. To review and take action on Interlocal Agreement for storage and maintenance of election equipment.
27. To review and discuss any agenda items to be placed on the upcoming District meeting agenda and to schedule same.
28. To meet in Executive Session pursuant to Texas Government Code §551.071, §551.072, §551.074, §551.076 to discuss District real estate, personnel matters or to discuss legal matters determined by district counsel which pursuant to the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas requires private consultation with the District.
