

## **MEETING NOTICE**

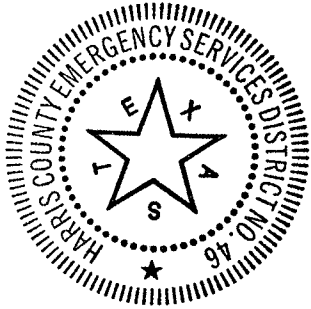
### **HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 46**

10. To receive the presentation regarding the Commission for the Accreditation of Ambulance Services.
11. To review, discuss and take action on transition matters including rebranding the Department as a result of transitioning operation from AVFD to the District.
12. To review, discuss and take action on any necessary repairs for equipment, apparatus and facilities in service to the District.
13. To review, discuss and take action on submittals by the Department of thirty (30) day advance request(s) for purchase of needed District assets.
14. To review, discuss and take action on approval of expenses related to upcoming and completed training classes for the District Commissioners, fire and EMS personnel and volunteers and administrative staff, including courses materials, equipment, lodging and other similar per diem expenditures.
15. Review, discuss and take action to confirm the date for any future meetings including the next regular District meeting scheduled for August 21, 2017.
16. Discuss any new items which need to be on the agenda for the subsequent District meetings including the regular District meeting.

17. Receive public comment.

To meet in Executive Session pursuant to Texas Government Code §551.071, §551.072, §551.074 and §551.076 to discuss District real estate, personnel matters or to discuss legal matters determined by district counsel which pursuant to the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas requires private consultation with the District.
