- 8. To discuss and take action on the imposition of early additional penalty for collection costs for taxes imposed on personal property on delinquent taxes pursuant to §33.11 of the Property Tax Code and adoption of a Resolution regarding same.
- 9. To review, discuss and take action regarding revisions needed to the District's 2017 Budgets or 2018 Budgets.
- 10. To review, discuss and take action on the report received from the Fire Chief.
- 11. To review, discuss and take action on the EMS report received from the Atascocita Fire Department.
- 12. To review, discuss and take action on the fire and rescue report received from the Atascocita Fire Department.
- 13. To review, discuss and take action on the administrative and facilities reports received from the Atascocita Fire Department.
