

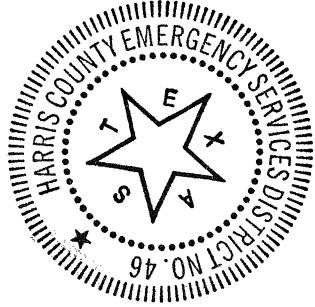
MEETING NOTICE

The District will consider and act upon the following matters:

1. Call meeting to order and establish a quorum.
2. To approve the Minutes of prior meeting(s).
3. To receive a financial report from Mary Anne Sokol, District bookkeeper and take any necessary action regarding the report.
4. To pay District bills and approve commissioner submittals pursuant to Texas Health and Safety Code §775.038(a-1).
5. To review, discuss and take action on granting exemptions for 2019.
6. To review, discuss and take action on the Department reports.
7. To review, discuss and take action on the Station 29 project.
8. To review, discuss and take action regarding long-range strategic planning committee matters.
9. To review, discuss and take action regarding retaining a sales tax consultant to help the District improve collections and provide an analysis of the District's sales tax collections.
10. Review, discuss and take action on submittals of thirty (30) day advance request(s) for necessary purchases related to the provision of emergency services in accordance with the current District Budget.
11. To review, discuss and take action for the sale or disposal of obsolete surplus and/or salvage property pursuant to Texas Health and Safety Code §775.0735.
12. To review, discuss and take action on any necessary repairs of equipment, apparatus and facilities in service to the District.
13. Review, discuss and take action to confirm the date for any future meetings including the next regular District meeting scheduled for May 20, 2019.
14. Discuss any new items which need to be on the agenda for the subsequent District meetings including the regular District meeting.
15. Receive public comment.
16. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.
17. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.

18. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
19. Review and take action on District real estate matters and personnel matters discussed in closed session.
20. Adjournment.
