3. To review, discuss and take action on District 2018 Audit.

6. To review, discuss and take action regarding the District's long term debt service obligations.
7. To pay District bills and approve commissioner submittals pursuant to Texas Health and Safety Code §775.038(a-1).

14. To review, discuss and take action regarding long-range strategic planning committee matters.
15. To review, discuss and take action regarding the Station 29 remodel project.
16. To review, discuss and take action regarding District purchases pursuant to the District budget.
17. Review, discuss and take action on submittals of thirty (30) day advance request(s) for necessary purchases related to the provision of emergency services in accordance with the current District Budget.
18. To review, discuss and take action for the sale or disposal of obsolete surplus and/or salvage property pursuant to Texas Health and Safety Code §775.0735.
19. To review, discuss and take action on any necessary repairs of equipment, apparatus and facilities in service to the District.
