The District will consider and act upon the following matters:

1. Call meeting to order and establish a quorum.
2. To review and discuss the appointment of a new District commissioner to fill the Board vacancy as permitted by Texas Health and Safety Code §775.0445.
3. To approve the Minutes of prior meeting(s).
4. To receive a financial report from Mary Anne Sokol, District bookkeeper and take any necessary action regarding the report.
5. To review, discuss and take action regarding the District's long term debt service obligations.
6. To pay District bills and approve commissioner submittals pursuant to Texas Health and Safety Code §775.038(a-1).
7. To review, discuss and take action regarding revisions needed to the District's 2019 Budgets.
8. To review and discuss the proposed District's 2020 budget.
9. To review the District's 2019 appraisal valuations, 2019 effective tax rate calculations and 2019 tax rate scenarios.
10. To propose the 2019 District tax rate.
11. To discuss and schedule any necessary public hearings to adopt the District 2019 tax rate.
12. To review, discuss and take action on the Department reports.
13. To review, discuss and take action regarding long-range strategic planning committee matters.
14. To review, discuss and take action regarding the Station 29 remodel project.
15. To review, discuss and take action regarding District purchases pursuant to the District budget.
16. Review, discuss and take action on submittals of thirty (30) day advance request(s) for necessary purchases related to the provision of emergency services in accordance with the current District Budget.
17. To review, discuss and take action for the sale or disposal of obsolete surplus and/or salvage property pursuant to Texas Health and Safety Code §775.0735.
18. To review, discuss and take action on any necessary repairs of equipment, apparatus and facilities in service to the District.

19. Review, discuss and take action to confirm the date for any future meetings including the next regular District meeting scheduled for September 16, 2019.
20. Discuss any new items which need to be on the agenda for the subsequent District meetings including the regular District meeting.
21. Receive public comment.
22. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas and Tax Code §323.3022 to discuss sales tax matters.
23. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
24. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
25. Review and take action on District real estate matters and personnel matters discussed in closed session.
