
The District will consider and act upon the following matters:

7. To pay District bills and approve commissioner submittals pursuant to Texas Health and Safety Code §775.038(a-1).
8. To review and take action on matters related to COVID-19.
9. To review, discuss and take action on the Station 29 renovation or reconstruction.
10. To review, discuss and take any necessary action related to the construction of the District's maintenance facility.
11. To review, discuss and take action related to the financing of two (2) new pumpers.
12. To review, discuss and take action on the Department reports.
13. Review, discuss and take action on submittals of thirty (30) day advance request(s) for necessary purchases related to the provision of emergency services in accordance with the current District Budget.
14. To review, discuss and take action for the sale or disposal of obsolete surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
