
The District will consider and act upon the following matters:

6. To pay District bills and approve commissioner submittals pursuant to Texas Health and Safety Code §775.038(a-1).
7. To review, discuss and take action regarding the purchase of BBVA USA by PNC Bank and the impact that will have on the District's banking needs.
8. To review, discuss and take action regarding electronic deposits related to the District's property tax account, sales tax account, and EMS collections account.
9. To review and take action on matters related to COVID-19.
10. To review, discuss and take action on the Station 29 reconstruction.
11. To review, discuss and take any necessary action related to the construction of the District's maintenance facility.
12. To review, discuss and take action on the Department reports.
13. To review and take action on 2022 budget and 2021 tax rate adoption planning.
14. To review, discuss and take action on acquiring property from RHL Humble Oil Field Corporation near the District's Rustic Timbers property.
15. Review, discuss and take action on submittals of thirty (30) day advance request(s) for necessary purchases related to the provision of emergency services in accordance with the current District Budget.
16. To review, discuss and take action for the sale or disposal of obsolete surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
17. To review, discuss and take action on any necessary repairs of equipment, apparatus and facilities in service to the District.
