- To review, discuss and take action for the sale or disposal of obsolete surplus and/or salvage property pursuant to Texas Health and Safety Code §775.251.
- 15. To review, discuss and take action on any necessary repairs of equipment, apparatus and facilities in service to the District.
- 16. To review, discuss and take action regarding the collapsed drain at Station 19.
