The District will consider and act upon the following matters:

3. To review, discuss and take action on any matters related to the Station 29 construction project and District's maintenance facility including the approval of any certified pay applications received from Martinez Architects.
4. To receive a sales tax report from ESD Tax Management Services.
5. To receive a financial report from Mary Anne Sokol and take any necessary action regarding the report.
6. To pay District bills and approve commissioner submittals pursuant to Texas Health and Safety Code §775.038(a-1).
7. To review, discuss and take action on granting exemptions for 2023.
8. To designate the Harris County Tax Assessor-Collector's Office to prepare the District's No New Revenue Tax Rate and related tax rate calculations for 2023.

10. To review, discuss and take action on the Department reports.
11. To review, discuss and take action on submittals of thirty (30) day advance request(s) for necessary purchases related to the provision of emergency services in accordance with the current District Budget.
12. To review, discuss and take action on the purchase of a new Chevrolet Tahoe in accordance with the District's current Strategic Plan.
13. To review, discuss and take action on the purchase of a new pickup truck in accordance with the District's current Strategic Plan.
14. To review, discuss and take action regarding the remount of a District ambulance box onto a new chassis.
15. To review, discuss and take action on the purchase of a Sutphen Corporation pumper.
16. To review, discuss and take action for the sale or disposal of obsolete surplus and/or salvage property pursuant to Texas Health and Safety Code §775.0735.
17. To review, discuss and take action on any necessary repairs of equipment, apparatus and facilities in service to the District.

18. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel or to discuss sales tax matters as permitted by Tax Code §323.3022.
