12. To review, discuss and take action on submittals of thirty (30) day advance request(s) for necessary purchases related to the provision of emergency services in accordance with the current District Budget.
13. To review, discuss and take action for the sale or disposal of obsolete surplus and/or salvage property pursuant to Texas Health and Safety Code §775.0735.
14. To review, discuss and take action on any necessary repairs of equipment, apparatus and facilities in service to the District.
15. To receive a report from the governmental relations committee regarding the 2025 legislative session.
16. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel or to discuss sales tax matters as permitted by Tax Code §323.3022.
17. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
18. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
19. Review and take action on District real estate matters and personnel matters.

20. Discuss any new items which need to be on the agenda for the subsequent District meetings, including the regular District meeting set for March 17, 2025.
21. Receive any announcements from the Board of commissioners or the Department staff.
